# Helping you to support your child

**Community Children's Nursing team** 

Children's continuing care is where specialist assessment and a multi-agency package of care is needed to support the family caring for a child or young person with multiple, complex and enduring health care needs due to disability, accident, life limiting or sudden illness.

#### **Our service**

This leaflet tells you how assessment, funding and arrangement of care packages takes place, in accordance with the continuing care pathway described in the National Framework (see above).

### Why we're here

We work with parents, carers, and other professionals to:

- ensure a smooth transition and discharge of children with complex medical needs from hospital to home
- assess children's and family's needs using the National Framework including talking with other healthcare professionals such social workers, Early Support and members of the extended multidisciplinary team.
- present the assessment and suggestions for the continuing care package to health and social care commissioners, who then fund the most appropriate and costeffective package e.g. staff to care for the child for a set number of hours per week in the home
- provide information and support for professionals, parents and carers relating to continuing care.
- monitor and review the quality and effectiveness of care packages once in place

We are involved with teaching a variety of nurse students. We will ask your permission before any of our nurses visit with a student.

## Referrals and what happens next

 Referrals can be accepted from any health or social care professional e.g. GP or social worker who thinks a continuing care package may be needed.

# Referral forms can be obtained from CCNT on 0208 464 7578.

- Once a written referral has been received by the Continuing Care Health Assessor, we will fully involve parents and other professionals in the assessment, and take into account the wider needs of the family.
- The continuing care assessment tool and checklist will be completed by the Nurse Assessor within 7 working days of receiving the referral.
- This assessment tool determines if the child's needs meet the criteria for continuing care support.
- If the child's needs don't meet the criteria, we will let the parents and referrer know, and describe other ways in which they may get some help.
- If the child requires continuing care, a supporting statement and decision paper will be presented to the Commissioning Team at the Specialist Support and Disability Panel who decide and fund the care package.
